"Ardex A35-mix",

- one layer of 30 mm Rockwool SeaRox SL 480 (density 200 kg/m³, manufactured by Rockwool)
- one layer of 40 mm Ardex A35-mix (density approx. 1850 kg/m³) which consists of grey powder cement, plastpowder and 0-8 mm stones.

Approved for use as a horizontal fire retarding division of class A-60.
